INDIAN RAILWAY WELFARE ORGANISATION MEMORANDUM OF ASSOCIATION

1. NAME OF THE SOCIETY:

The name of the Society is Indian Railway Welfare Organisation (hereinafter referred to as IRWO)

2. REGISTERED OFFICE OF THE SOCIETY:

The registered office of IRWO will be located in Union Territory of Delhi and is situated at Northern Railway Complex, Shivaji (Minto) Bridge (Behind Shanker Market), New Delhi – 110001.

3. AIMS AND OBJECTS:

The aims and objects for which the Society is established are as under : -

- (a) To promote Social Welfare Schemes such as providing all possible help to acquire accommodation to serving railway personnel, retired railway personnel, spouses of deceased railway personnel, personnel of Public Undertakings under the Ministry of Railways and the personnel of IRWO.
- (b) To do all such things as are incidental or considered conducive by IRWO to attainment of the above objects or any of them.
- 4. All the activities of the Society as mentioned from 3(a) to 3(b) above will be carried out without any profit. All the incomes, earnings, movable, immovable properties of the Society shall be solely utilized and applied towards the promotion of its aims and objects only as set forth in the Memorandum of Association. Being a non-profit making Organisation, no payments will be made or transferred directly or indirectly by way of dividends, bonus, profits or in any manner what-soever to the present or past beneficiaries of the Society or to any person claiming through any one or more of the present or the past beneficiaries. No beneficiary of the Society shall have any personal claim or any, movable or immovable properties of the Society or make any profits whatsoever.

5. GOVERNING BODY

The names, addresses, occupations and designations of the ex-officio present members of the Governing Body to whom the management and affairs of IRWO are entrusted as required under Section 2 of the Societies Registration Act., of 1860 (Punjab Amendment Act 1957), as extended to the Union Territory of Delhi are as follows:
