Sub: Delay in execution of conveyance deed in respect of DUs allotted by IRWO

There have been abnormal delays in signing of Conveyance Deeds by the allottees in spite of reminders from time to time. The matter has been reviewed and it has been decided to enhance the penalties for the delays as per details enclosed in Annexure-A in order to cover the enhanced cost of establishment and also to curtail the delays in signing of Conveyance Deed.

For unsold units of Jaipur, Kota & Sonipat project allottees are advised to execute their Conveyance Deeds within six months of possession of their Dwelling Units. Penal charges @ Rs.1,000/- + applicable GST per month shall be collected from the allottees in case the Conveyance Deed is not signed within six months of possession.

Allottees of Jaipur phase-III project are advised to get the registration done by 31.05.2024.A penalty of Rs.1,000/- per month or part thereof + GST shall be levied for registrations beyond 31.05.2024.

All the concerned officers of IRWO are requested to take appropriate action for compliance.
